RFID tracking and marker technology ensure that bins in the truck or at the shredder can be unlocked auto-

matically and without contact, but also tracked seamlessly. This provides a better overview of the distribution of collection bins and facilitates the obligation to provide evidence in favor of compliance with the EU-DSGVO. Further advantages: Existing collection containers can be retrofitted with the electronic lock. In addition, it is possible to fully manage containers without an electronic lock in the SECOLO system by means of a barcode.
